Although it was a short week, we have a few important reminders and updates to share. Please take a moment to read through the following information:

Important Reminders:

- 1. Just a friendly reminder to submit your annual dues payment of \$400 before the deadline on July 15, 2023. You can find details about the three convenient <u>payment methods</u> on the website at www.lottivuemeadows.org. The new online credit card payment option has been very popular since the website was launched last week.
- 2. We kindly request that all community members complete the "<u>Co-Owners</u> <u>Registration</u>" form on the website. By doing so, the Board can ensure that we have the most up-to-date contact information for everyone in our neighborhood.

Community Updates:

- 1. Good news! The contractor hired by the developer successfully replaced nearly a dozen squares of concrete throughout the community.
- 2. The vote to amend the bylaws to allow above ground pools did not pass. Per our bylaws, an amendment requires a two-thirds affirmative vote from qualified participants. We received a total of 32 votes (23 yes and 9 no) out of the 54 qualified ballots mailed out. Although an overwhelming majority of the votes received were in favor of the amendment, 22 homeowners did not respond with a vote in favor or against the measure, and therefore the two-thirds threshold was not met.
